The Yemassee Shrimp Festival will be held on Thursday, September 16-Sunday, September 19. The festival spirit generated by our concessionaries is an important part of our festival. The festival will be set up around our Yemassee Municipal Complex on Salkahatchie Road and Town Circle.

The street dance will be held on Friday night and the Mayor's Ball will be Saturday night.

If you wish to participate in our 17th annual Shrimp Festival, please complete the enclosed application and return it with your payment.

GUIDELINES

1. The Yemassee Shrimp Festival reserves the right to refuse any vendor that does not conform to our guidelines and the information submitted in your application. What you list is what you are expected to sell.
2. The festival committee will control the number and type of items sold and will determine vendor location. No snap-pops or sexually explicit materials are allowed.
3. Any vendor may set up beginning at 12:00 noon and ending 6:00 p.m. on Thursday, September 16, 2010. **ALL VENDORS MUST BE IN PLACE AND SET UP BY 3:00 p.m. ON FRIDAY! NO VENDORS WILL BE ALLOWED AFTER THIS TIME!!!** Deliveries by vehicle must be before 9:00 a.m. on Saturday. Rules will be enforced by the Yemassee Police Department. We ask that all vendors remain open until 9:00 p.m. on Friday night, but you may stay open longer if you wish.
4. Vendor **MUST** fit on a **20x20** spot, including the tongue of the trailer. If using a tent, **ALL** sides must remain up.
5. Booths must be set/assembled by the participant. Tables and tents are not provided by the festival.

6. Food participants are responsible for complying with all State Health Department regulations. (enclosed)
7. All persons selling items are responsible for collecting S.C. sales tax.
8. The festival provides electrical power to the pole outlet only. All adaptors, fuses, cords, etc. will be the sole responsibility of the participant.
9. Application fee is non-refundable on accepted applicants.
10. Fees must accompany applications. If you are not awarded space, your funds will be returned to you.
